Established in 1987, the Brevard Schools Foundation is the direct-support, non-profit organization which matches community resources with the needs of Brevard Public schools. Brevard Schools Foundation fills educational funding and opportunity gaps at all of our 82 public schools for 73,000 students and 5,000 teachers by supporting innovation, engaging communities and changing lives.

Brevard Schools Foundation provides administrative oversight and contracts with Brevard Cultural Alliance to implement and manage Next Generation Artist Residencies.

This grant will support residencies at 12-15 different schools, providing 30-50 instructional hours per residency, and serve an average of 80 students per school. Activities will immerse participating students in a particular art form; enhance school curriculum and teachers' instructional plans; all while focusing on acquisition of 21st century skills. The program also facilitates professional development for both educators and artists through their collaborative work.

Goals:

- Promote arts and culture as an integral part of education, and personal and community development.
- Increase prominence of arts in participants' lives; improve their skills, perceptions and understanding about the arts in general and artistic activity
- Channel existing resources within the arts sector for the benefit of Brevard students and schools.
- Enrich existing school programs, thereby assisting Brevard Public Schools in fulfilling its goal of enhancing student's lives by providing the highest quality education in a culture of dedication, collaboration and learning.
- Facilitate schools' implementation of innovative educational models to enhance students' engagement in the learning process.
- Facilitate students' acquisition of 21st century skills

- Implement STEAM educational experiences
- Provide professional development for participating educators and teaching artists

Objectives:

- Provide a minimum of 12 Brevard public schools with artist residencies during 2019-20 school year
- Participation in artist residency by at least 10% of the population at each selected school
- At least 50% of participating schools will be Title 1 or magnet schools
- Enhance participating students' artistic skills, measured by participation and evaluation
- Each residency will deliver 21st century skills education and include cross-curricular integration
- At least 4 of the residencies will be STEAM Artist Residencies, providing STEAM education experiences
- Enhance existing curriculum and teachers' plans as measured through residency plan, reporting and evaluation
- Arts integration into other subject areas as measured through residency plan, reporting and evaluation
- · Create teacher/artist teams that collaborate to plan, implement and evaluate residency activities

Activities:

- 1. Recruitment of a team of highly qualified professional teaching artists of diverse artistic disciplines to provide instruction
- 2. Planning/consultation sessions between program administrators, partners and school district specialists to ensure program alignment with BPS' Strategic Plan and current needs of schools and to review the teaching artists team.
- 3. BPS specialists distribute Next Generation Artist Residency information and application information to schools.
- 4. Application materials are also available online on the BCA website; with comprehensive information on each available teaching artist, their discipline and the type of activities they offer.
- 5. Schools submit an application that includes their preference of instructor (selected from the group of BCA teaching artists) and a description of the type of residency they want to implement.
- 6. Applications received from schools are reviewed by Brevard Schools Foundation staff, BCA staff and BPS specialists to select host schools based on demographics, program goals and resources.
- 7. Selected schools' administration and faculty meet with the teaching artist and BCA staff to devise a residency plan that specifies schedule, lessons/activities, objectives and evaluation plan.
- 8. Residency classroom sessions begin. Coordination is provided by BCA to monitor program quality, oversee logistics and assure school staff satisfaction.
- 9. Residencies culminate with sharing sessions, art exhibitions and/or performances showcasing participant achievement.
- 10. Each artist/teacher team conducts evaluations of each student's accomplishment based on final project/performance.
- 11. Artists and teachers complete their school residency program report. BCA Program Manager analyzes each school report to assess achievement of outcomes based on pre-determined objectives.

12. Final program report is compiled by BCA Program Manager to determine outcomes achieved, evaluate the program as a whole, and assess ways to continually improve program.

Brevard Schools Foundation is responsible for fiscal and administrative oversight. Brevard Cultural Alliance is contracted by Brevard Schools Foundation to implement and manage Next Generation Artist Residencies.

This partnership has proven beneficial to students, educators and professional artist instructors over a number of years. Each year a Memorandum of Understanding (MOU) is executed between BSF and BCA for Next Generation Artist Residencies.

Established in 1987, the Brevard Schools Foundation is the direct-support, non-profit organization which matches community resources with the needs of Brevard Public Schools. Support may be in the form of financial contributions or in-kind gifts of goods or services. Brevard Schools Foundation solicits funds for Brevard Public Schools through grants and/or private resources. These supplement dollars available through the school district, to provide the means for classroom teachers to undertake special projects not supported through existing budgets and programs. The Brevard Schools Foundation supports all 82 public schools in Brevard County encompassing over 73,000 students.

Brevard Schools Foundation has ranked in the Top 10 national education foundations for the past three years for its role in supporting public education. Since its establishment the Brevard Schools Foundation has provided more than \$47 million is benefit to Brevard Public Schools.

Foundation Programs:

- The Supply Zone for Teachers The Supply Zone's mission is to serve the educational and creative needs of children in Brevard Public Schools by providing free school supplies to teachers at high-poverty schools. To date, more than \$2 million in supplies have been distributed to more than 4,000 teachers.
- Take Stock in Children -- A comprehensive drop-out prevention program that helps at-risk, low-income middle and high school students stay in school, earn a high school diploma, graduate from college and enter the workforce.
- Space Week Each year the Foundation introduces more than 5,000 sixth grade students to science, space and space exploration through classroom learning designed around STEM education, and a full day study trip to Kennedy Space Center.
- Classroom Grants Classroom grants enhance education by helping teachers undertake special projects not supported through existing budgets and programs. Nearly \$500K has been awarded through more than 600 grants that have improved student achievement, especially amongst hard to reach children.
- Scholarships The Foundation manages a scholarship program that in 2018 awarded 76 scholarships totaling in excess of \$73,000 for graduating seniors.
- Recognition Events Each year the Foundation applauds excellence in education by bringing attention to the special contributions made by educators, support staff, administrators, volunteers, business partners, and others who serve over 73,000 students at the annual ABC Awards.

These Next Generation Artist Residencies provide employment opportunities for professional artists, thereby supporting their creative endeavors and advancing their careers. The purchase of goods and materials needed to implement the residencies also contributes to Brevard's economy.

During the 2016-17 school year, over 2,500 students were directly served through Next Generation Artist Residency program instruction. The residencies program will emphasize hands-on learning, mentoring and the processing of sequential steps to complete a project. The program will create opportunities for cross-curricular integration with an emphasis on participants' acquisition of 21st Century Skills (critical thinking, problem solving, creativity, innovation). Through art creation and performance participants will also explore careers in arts related fields.

Some of the residencies will focus specifically on enhancing technology literacy and teach STEM (science, technology, engineering and mathematics) curriculum through arts integration, widely known as STEAM education. This technology-based subset of next Generation Artist Residencies, Technology Through the Arts, will provide learning experiences that humanize technology and expand the possibilities of understanding and using it in creative and innovative ways.

Participation in the program will not be limited to art teachers; educators from other subject areas will have the opportunity to explore the potential of the arts to add innovation and novelty to teaching.

The program will be promoted through Brevard Schools Foundation and Brevard Cultural Alliance (BCA) websites and social media platforms, as well as through diverse school district channels of communication (website, email, publications, etc.). As the designated local arts agency of Brevard County, BCA creates opportunities to promote Brevard arts and cultural initiatives online and through social media.

Next Generation Artist Residencies will be featured in BCA's marketing and promotion platforms, including their strategic public relations efforts. Video excerpts of artist residency activities will also be featured on Brevard Cultural Alliance's YouTube page and website, and then cross-promoted through social media.

Brevard Schools Foundation was established as a 501 (c)(3) organization in 1987. The organization conducts an annual audit.

Through continued partnership between Brevard Schools Foundation and Brevard Cultural Alliance and with grant opportunities and corporate funding, these unique school-based artist residencies will continue to be implemented and offered for the benefit of Brevard students.

- 1. As part of the planning sessions each artist/teacher teams will develop with BCA Program Manager's supervision an evaluation plan that specifies methods and/or tools (surveys, direct observation, rubric, etc.) to evaluate student performance, focusing on the ability of students to apply arts concepts and skills learned during the residency to their artwork or performance piece.
- 2. Program manager will conduct site visits to observe artists' and teachers' collaborative work and discuss their experiences within the program; also to gain informal feedback from the participants. This information, along with anecdotal reports by teachers, will be used in final reporting to complement quantitative data from the students' performance assessments/surveys to evaluate the residencies and determine outcomes achieved.
- 3. Teachers and artists will conduct the students' evaluations based on the plan they devised in collaboration with BCA Program Manager. Quantitative data collected is provided for inclusion in residency final report.
- 4. Upon conclusion of the residencies, artists and teachers will compile a residency report for each participating school consisting of an overview of program activities, students' evaluation data and responses to questions focused on the achievement of goals, and outcomes and assessment of impact of the activities on students and school programs.
- 5. All quantitative data and qualitative information from each of the school residency reports from all participating schools will be used by program managers to evaluate Next Generation Artist Residencies based on pre-established goals. Final report findings will help to identify program strengths and weaknesses, and paths for continued improvement.

6. The final report, which compiles and analyzes all data from all residencies, is presented to project funders, the Boards of Brevard Schools Foundation and Brevard Cultural Alliance, and the Brevard School Board.

Students of varying abilities successfully participate in Next Generation Artist Residencies. Accommodations are made for students of different abilities or needs to participate fully and have positive residency experiences.

A recent example of accessibility initiatives is the "Art Beyond Boundaries" project, which pairs at-risk boys who are in residence at the Melbourne Center for Personal Growth (the "Center") with high school students with disabilities who participate in the Florida High School High Tech (HSHT) program at Heritage High School in Palm Bay, Florida.

"Art Beyond Boundaries" facilitates the boys in this program gaining a set of skills, experiences, relationships and behaviors that help them develop into successful and contributing adults by participating in artist residency projects jointly with students with disabilities.

Artist instruction takes place twice weekly at Heritage High and once weekly at the Center. The multiphase final product of the project is the creation of a community garden at the school, which provides students the opportunity to cultivate edible plants and fruit. The first phase of the program (Feb-June 2018) includes the creation of six planters under the instruction of teachers from Verdi Eco School, in Melbourne. During the second phase (July-Dec 2018) highly-qualified teaching artists will work with participants on the creation of fully-accessible walking paths in the garden incorporating mosaic and other types of art and created by the Heritage High students and the Center's at-risk young men working together.

The project uses the visual arts to foster inclusion, respect and dignity for people with developmental disabilities.
