**RESOLUTION OF THE STATE EXECUTIVE COMMITTEE OF THE
FLORIDA DEMOCRATIC PARTY DESIGNATING ELECTORS
FOR PRESIDENT AND VICE-PRESIDENT OF THE UNITED STATES**

WHEREAS, Section 103.021(1), Florida Statutes, requires the Governor to nominate only the presidential electors recommended by the state executive committee of each respective political party;

WHEREAS, Section 103.021(1), Florida Statutes, requires each such elector to be a qualified elector of the party he or she represents who has taken an oath that he or she will vote for the candidates of the party that he or she is nominated to represent; and

WHEREAS, Section 103.021(1), Florida Statutes, requires the state executive committee of each political party to recommend, by resolution, candidates for presidential electors and to deliver a certified copy thereof to the Governor before September 1 of each presidential election year.

NOW, THEREFORE, BE IT RESOLVED, that the State Executive Committee of the Florida Democratic Party, nominates the following candidates as presidential electors for President and Vice-President of the United States:
