In March 2021, the Florida Department of State's Division of Library and Information Services **surveyed Florida's public libraries to** identify Internet usage policies and filtering practices. There are 140 county and municipal public library administrative units and member libraries in Florida's 67 counties. A per-county overview of these practices follows.
