### Call to order and roll call

The virtual meeting was called to order at 9:02 a.m. Eastern on September 24, 2021, by Chair Linda Waters. The roll was taken using the webinar attendees list.

### Adoption of agenda

### Approval of minutes from the July 28, 2021 meeting

Tim Rogers made a motion to approve the draft minutes. The motion was seconded, and the minutes were unanimously approved.

### Meeting process guidance and discussion

Division Director Amy Johnson provided information and a process overview. The Council developed funding recommendations for the 63 American Rescue Plan Act (ARPA) applications requesting \$8,189,641. There was \$6,738,948 to allocate in funding recommendations (\$6,735,385 in ARPA funds and \$3,563 in LSTA funds).

### ARPA project application review, scoring

Council members provided scores and application comments for each application.

### **ARPA project application review, funding**

The Council discussed funding recommendations for projects that scored 60 points and above.

### **Adoption of the funding recommendations for ARPA project applications**

Christine Boatright made a motion to adopt the project funding recommendations as outlined below. The motion was seconded, and the recommendations were unanimously approved. This motion leaves a balance of \$66,067.

To allocate the remaining funds at a future meeting, the 11 applications that were not recommended for funding will be revised and strengthened.
