1. Per section 101.62, F.S., only the following persons and entities listed in law are entitled to access files pertaining to voters who have requested vote-by-mail ballots in the event of an election.

- a canvassing board
- a political party or official thereof
- a candidate who has filed qualification papers and is opposed in an upcoming election
- registered political committees


