### Active Program

An Active Program is a planned, live event intended for a group of participants. Active programs are held in person or virtually. Examples of active programs include but are not limited to:

- Film screenings
- Lectures
- Storytimes
- Literacy classes
- Cosplay cons
- Summer reading fun fairs
- Puppet shows
- Summer-themed arts and crafts

Note: For data reporting purposes, count virtual or streaming live events as Active Programs.

Count views of recorded events as Self-Directed Programs. Exclude programs sponsored by external groups that use library facilities.

When programs are offered as a series, count each individual program in the series. For example, a film series offered once a week for eight weeks should be counted as eight programs.

### Self-Directed Programs

A Self-Directed Program is created for individuals or groups to access and use, view or experience at their convenience. Examples of self-directed programs include but are not limited to:

- Video recordings of story times
- Teaching step-by-step arts and crafts, how to exercise, etc.
- Twitter-feed book discussions
- Virtual escape rooms

As a reminder, self-directed programs that the library purchased through a mass subscription should not be counted.

**Make and Take Kits**

Make and Take Kits are activity kits that library staff put together for patrons to take with them to complete on their own time.

For the “Total Number of Different Kits,” submit the number of different **types** of kits that your library created.

For “Total Number of Kits Provided to Patrons” you would count the total number of kits that you gave out to patrons.

For instance, if you provided one new kit each week for eight weeks, and 100 people took kits each week, you would report that you created eight **Total Number of Different Kits** and 800 **Total Number of Kits Provided to Patrons**.
