**Resolution No.2024-1**

**A Resolution of the State Executive Committee of the Constitution Party of Florida Approving the Selection of Presidential Electors for the 2024 General Election**

**WHEREAS**, the Constitution Party of Florida is an affiliate of the National Constitution Party headquartered in Lancaster, Pennsylvania; and

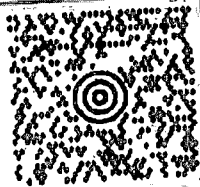

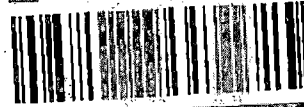
