## **Research Stipend Program Application**

The Division of Library and Information Services is pleased to announce a competitive stipend program for qualified researchers, sponsored by the Friends of the State Library and Archives of Florida. The program is intended to support exceptional projects utilizing the collections of the State Archives and State Library of Florida that can only be accessed on-site. Up to two applicants will be selected each year.

Selected applicants will receive \$1,000 to conduct research at the State Archives and State Library of Florida. An initial payment of \$500 will be distributed when the selected applicant arrives to conduct research. The remainder of the stipend will be distributed once the applicant has submitted a final report after completing their research in Tallahassee.

These payments will be reported to the IRS per federal requirements; winning applicants must provide us with their social security numbers for that purpose.

### **Who is Eligible to Apply?**

- Academic historians, graduate students and undergraduate students conducting research for a thesis, dissertation, article, book, documentary or other publicly-disseminated product.
- Community historians and independent researchers or writers conducting research for a project relating to the history of Florida or a Florida community or region, such as a book, documentary film, public exhibit or other publicly-disseminated product.
- K-12 teachers or professionals developing curriculum materials or other projects aimed at enhancing the study and teaching of Florida history.

### **Selection Criteria**

- Feasibility of the project and the availability of materials at the State Archives and State Library of Florida to support the project's stated goals.
- The project's creative use of archival and/or rare special collections materials at the State Archives and State Library of Florida that are unavailable from other institutions or online and can only be accessed on-site.
- The project's likelihood to substantially increase or enhance the understanding of some aspect of Florida history and culture or that of a Florida community or region.

## **Timeline**

To be considered, applications and supporting documents must be emailed or postmarked no later than 11:59 p.m. Eastern on **March 31, 2025**.

Applicants are responsible for reading the application instructions thoroughly and submitting all required materials by the deadline.

All applicants will be notified of the selection committee's decisions by **mid-April, 2025**.

## **Before You Apply**

All applicants must contact the State Archives (and/or the State Library if appropriate) for guidance regarding collections relevant to the proposed project.

## Application Checklist

To be considered, your application must contain ALL of the following components:

A complete application form, **typed or printed** with all required information provided. Incomplete applications will not be considered.

A current résumé or curriculum vitae.

A cover letter explaining your interest in the program and why your proposed project should be selected to receive a stipend.

At least one letter of reference from someone who can speak to your ability to carry out the proposed project. You may submit this letter separately from the other application components but it must be submitted by the application deadline.

- For graduate and undergraduate students, this should be a thesis/dissertation advisor or other professor.
- For a K-12 teacher or curriculum professional, this could be a department chair, principal or school district administrator.
- For a community historian or independent scholar, this could be a representative of a local historical society, museum, institution of higher learning or other institution.

The letter of reference should discuss:

- Your familiarity with the subject matter of your project; **and**
- Your understanding of historical research; **and**
- Your ability to complete substantial projects on schedule.

## Submitting Your Application

Email submissions are strongly encouraged.

When emailing your application, attach all required documents to a single email—preferably as Adobe PDF files to preserve their formatting.

If appropriate, indicate how this project fits into a larger work in progress. Describe the goals of your proposed project and how your community will benefit.

**Teachers:** Provide a description of the activities involved in your proposed project, including research and implementation. If appropriate, indicate how this project fits into a larger work in progress.

Explain why there is a need for such a project in your community, school, and/or school district.

Identify one or two state learning standards that you will address through your project. Describe the goals of your proposed project and how students will benefit. State the approximate number of teachers and students who will use your project products.

Describe plans to evaluate your project's success, especially its effect on student learning.
